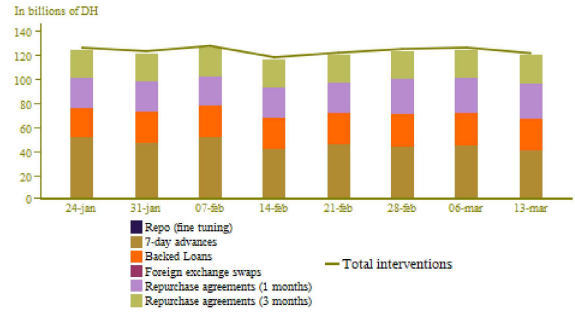

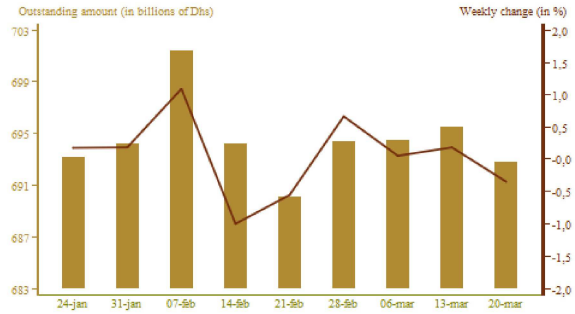

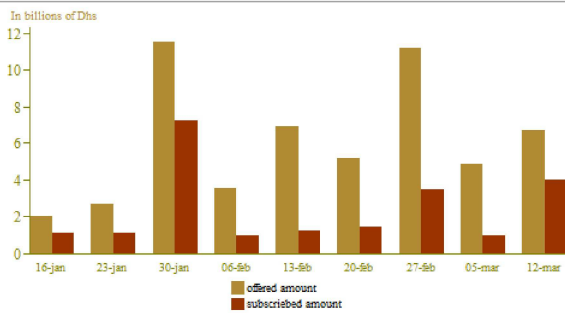

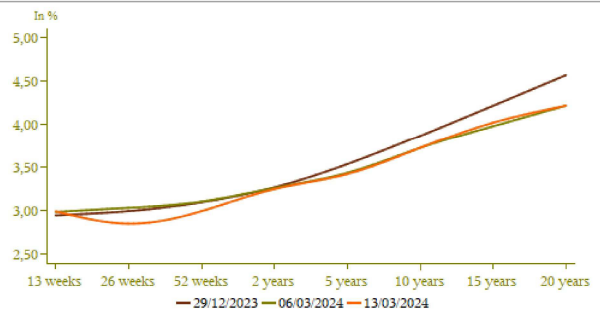

Secondary market yield curve (%)

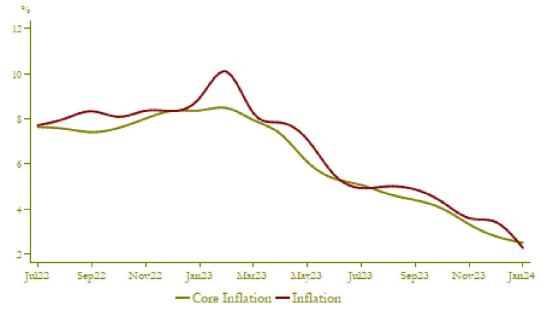

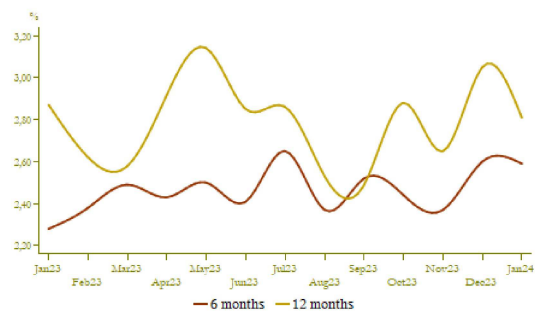

Time deposit rates (%)

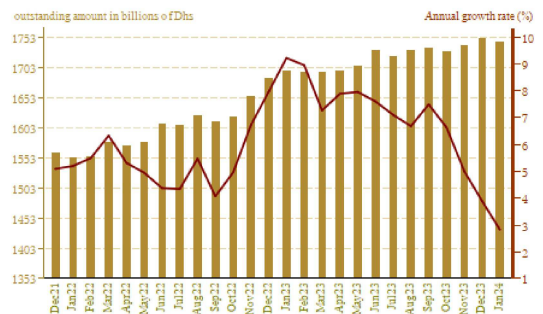

Evolution of M3

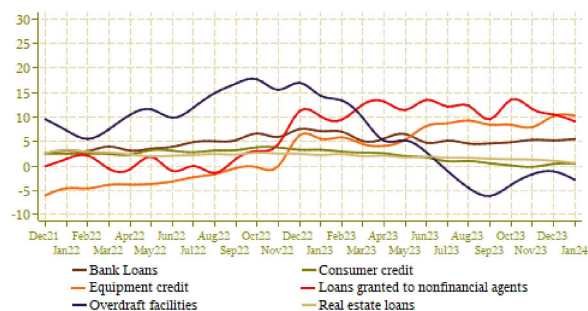
