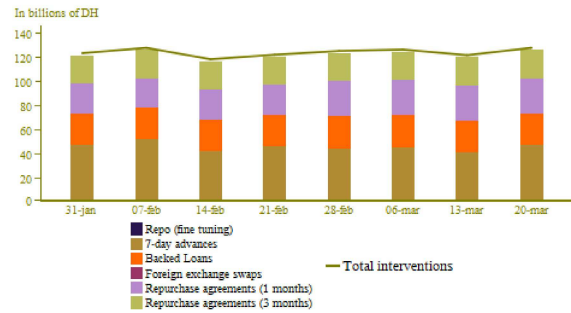

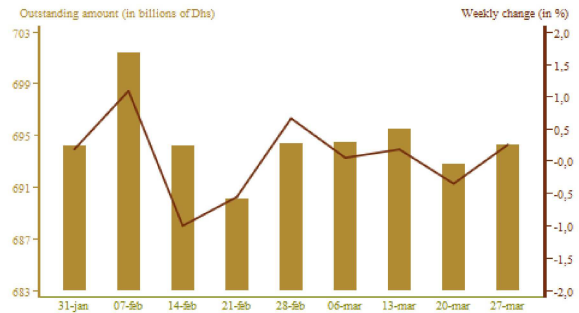

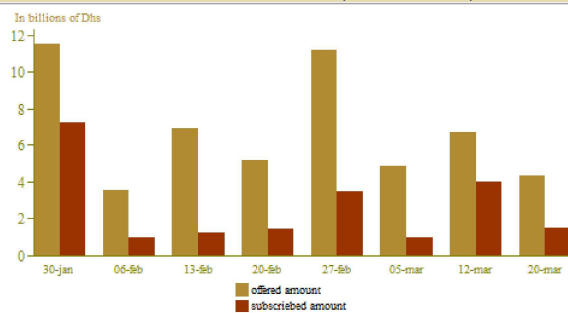

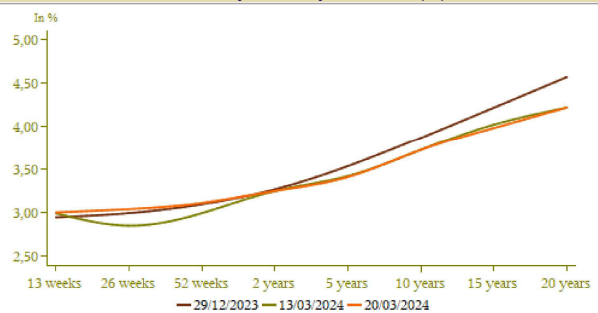

Secondary market yield curve (%)

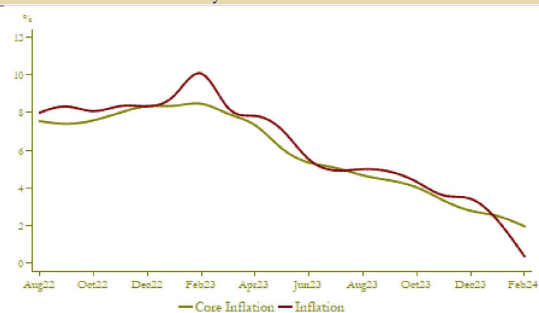

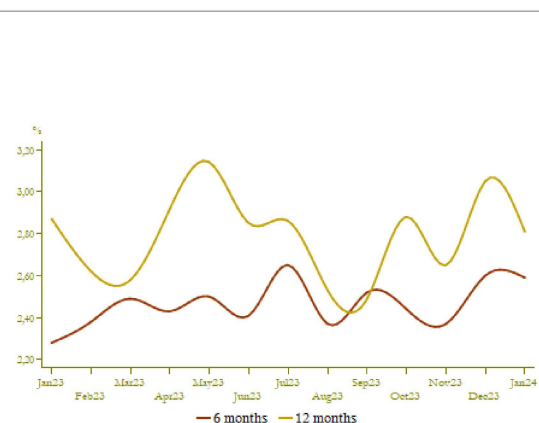

Time deposit rates (%)

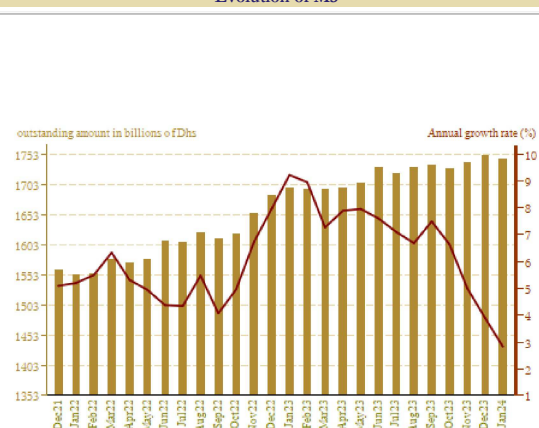

Evolution of M3

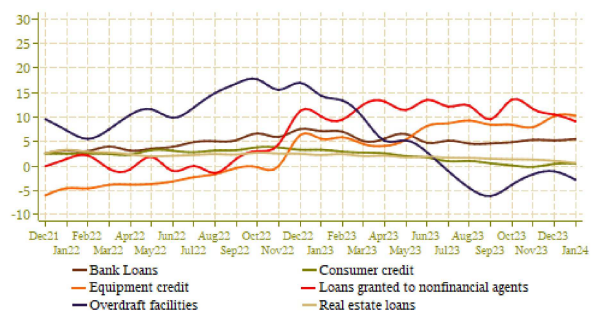

Evolution of Bank loans and its main counterparts (Year-to-year in %)

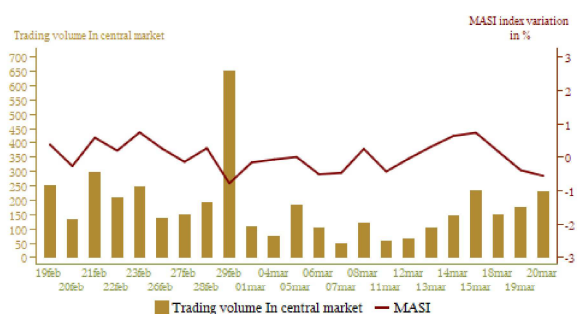
