


## Results of Bank Al-Maghrib quarterly survey on lending rates

The results of the quarterly survey on lending rates charged by banks to their nonfinancial customers in the third quarter 2016 show that the overall lending rate stood at 5.08% as against 5.25% a quarter earlier. In fact, except for consumer loans rates, which remained at the same level as the quarter before (6.64%), the interest rates on all credit categories registered a drop, standing at 4.95% for equipment loans, 4.98 % for cash advances and 5.34% for real estate loans.
