VI- Right to access to information safeguards

- Bank Al-Maghrib should respond to the request to access to the information within a period not exceeding twenty (20) working days starting from the request's reception.
- Bank Al-Maghrib may extend the period of twenty (20) working days for a similar period, in the following cases:
 - If Bank Al-Maghrib is unable to fully or partially respond to the request of the concerned person within the above-mentioned deadline;
 - If the request involves a large amount of information;
 - If it is impossible to provide the information within the above-mentioned deadline;
 - If its issuance requires prior consultation of third parties.

In any case, the interested person must be informed in advance of the extension, in writing or by e-mail, specifying the reasons for the extension.

- In case of emergency, where obtaining the information is necessary to protect the life, safety, or freedom of the individual, Bank Al-Maghrib shall comply to the request of access to information within three (3) days.
- The applicant may make a complaint to the:
 - Wali of Bank Al-Maghrib within a deadline of twenty (20) working days following the expiration of the statutory period for responding to the request or from the date of the receipt of the response.
 - The Right of Access to Information Commission within thirty (30) days after the expiration of the statutory period for responding to the complaint addressed to the Wali of Bank Al-Maghrib, or the date of the complaint's reception. The Commission should consider the complaint and inform the concerned person of the follow-up provided to it within a deadline of thirty (30) days from the date of receipt.
- The applicant has the right to appeal to the competent administrative court against the decision of the Wali of Bank Al-Maghrib within sixty (60) days, or as of the date of the Right of Access to Information Commission's reply to his complaint, or as of the date of expiry of the legal deadline for replying to the complaint.
- The collected information is used in compliance with the provisions of article 6 of the Law N° 31.13.
- All the information specified in compliance with the provisions of Article 7 of the Law N° 31.13 is excluded from the right of access to information.

V- Article reserved for personal data protection

Through this form, the applicant gives his/her consent to the processing of his/her personal data by Bank Al-Maghrib in order to receive, examine and respond to requests for access to information in accordance with Law 31-13 as well as to establish the corresponding statistics.

This processing has been the subject of a request for authorization from the CNDP under the number A-DAI-774/2020 dated March 12th, 2021.

The personal data collected may be transmitted to the persons in charge of the right of access to information within Bank Al-Maghrib, the Right of Access to Information Commission as well as the administrative and judicial authorities and court officers.
