

## Bank Al-Maghrib's quarterly survey on lending rates Q3-2023

The results of Bank Al-Maghrib's survey on lending rates for the third quarter of 2023 show an increase in the overall average rate by 10 basis points to 5.36 percent.

**By economic purpose,** the rates were 5.32 percent for cash facilities, 5.12 percent for equipment loans, 5.21 percent for real estate loans and 7.25 percent for consumer loans.

**By institutional sector,** the rates on loans granted to individuals and to **non-financial corporates** stood at 5.94 percent and 5.32 percent respectively. For **private non-financial companies' loans**, the rate was 5.36 percent, with 5.05 percent for large companies (LCs) and 5.75 percent for very small, small and medium-sized enterprises (VSMEs).
