

Bank Al-Maghrib's quarterly survey on lending rates Q2-2026

The results of Bank Al-Maghrib's survey on lending rates for the second quarter of 2026 show that the overall rate has increased by 15 basis points to 4.81 percent.

By economic purpose, the rates were 4.63 percent for cash facilities, 4.65 percent for equipment loans, 5.06 percent for real estate loans and 6.81 percent for consumer loans.

By institutional sector, the interest rates on loans stood at 5.59 percent for **individuals** and 4.71 percent for **non-financial corporations**. For **private non-financial companies' loans**, the rate was 4.81 percent, with 4.56 percent for large companies (LCs) and 5.20 percent for very small, small and medium-sized enterprises (VSMEs).
